Dear parent or carer

I hope my message finds you safe and well.

Following on from tonight's government announcement, I am writing to confirm that our academy, alongside all other schools and academies in England, will only be open to our most vulnerable pupils and the children of critical workers from tomorrow, Tuesday 5 January 2021. We must ask all other children to stay at home and complete their learning using our online platforms.

The remainder of this letter will outline the main things that parents and carers need to be aware of over the coming weeks.

### **Who should attend the academy tomorrow?**

The academy will be open to our most vulnerable pupils and the children of critical workers across all year groups. You can check whether your child is part of either of these groups by clicking [here](#).

### **When will my child be able to return to the academy?**

The Prime Minister in his announcement mentioned that schools and academies could be asked to operate in this way until at least the February half term.

We plan to keep in close contact with you and will be in touch as soon as we have the greenlight to welcome back more of our pupils.

### **Remote education arrangements for our children**

We have plans in place which mean that the pupils who must stay at home can continue their learning without disruption. Children will have daily contact with their teachers and will continue to be taught a wide range of subjects in line with their academy timetables where possible.

We will be taking a daily register and our teachers will closely monitor progression, adjusting pace or difficulty of work where necessary.

**Who should I inform if my child tests positive for the virus?**


